## **Notice Regarding Dissolution of Subsidiaries**

Sojitz Corporation today announced the dissolution of three subsidiaries, with details as follows.

### 1. NI Service Corporation

# (i) Company Overview

#### (ii) Reason for Dissolution

NI Service was established as a wholly owned subsidiary of the former Nissho Iwai Corporation to provide administrative, clerical and other support services. However, to enhance the management efficiency of the Sojitz Group, the operations of NI Service were transferred to Sojitz Shared Service Corporation (formerly Nissho Iwai Professional Services, Ltd.) As the process of disposing of NI Service's marketable securities and other assets has now been completed, the decision has been made to dissolve this company.

#### (iii) Outlook

Following a resolution by NI Service to dissolve the company on March 31, 2007, Sojitz plans to complete dissolution procedures in September 2007.

#### (iii) Outlook

Following a resolution by Nakatsu Estate to dissolve the company on March 30, 2007, Sojitz plans to complete dissolution procedures in December 2007.

The dissolution of the above three subsidiaries will have no impact on Sojitz's projected consolidated financial results for fiscal 2006, ending March 31, 2007.
