- I Organizational Reforms
- 1. Organizational Reforms (effective as of April 1, 2018)

[Audit & Supervisory Structure]

• The Internal Audit Committee, comprised of full-time Audit & Supervisory Board members, will be established under the Board of Directors to oversee the Internal Audit Dept.


[Domestic Network]

• The Sojitz Corporation, Osaka Office will be registered as a Sojitz Corporation branch, to be called the Kansai Office.

[Business Divisions]

- The Aerospace & IT Business Division, Infrastructure & Environment Business Division, and Energy Division will be reorganized into the Aerospace & Transportation Project Division, Machinery & Medical Infrastructure Division, and Energy & Social Infrastructure Division.
- The name of the Metals & Coal Division will change to the Metals & Mineral Resources Division.







[Corporate Departments]

- New corporate organizations—the **Corporate Sustainability Office**, **Business Innovation Office**, and **M&A Management Office**—will be established.
- The Executive Management Affairs Office, Business Group and Financial Planning Office will be reorganized.

2. Purpose of Organizational Reforms

[Auditing & Supervisory Structure]

• Establishing an Internal Audit Committee under the Board of Directors and having the Internal Audit Department conduct the internal audit under their instruction will lend greater independence to our auditing function, as well as strengthen the Board of Directors' supervisory functions with regards to execution.

[Domestic Network]

• By changing the name of the Osaka Office to the Kansai Office and dispatching a full-time officer there as head of the office, we will strengthen Sojitz Group's domestic network in the Kansai Region.

[Business Divisions]

- In aiming for further growth, Sojitz will combine the historically strong aerospace business with business related to airports and other transportation infrastructure, creating the Aerospace & Transportation Project Division and generating synergy between both business functions and talent.
- Through the creation of the Machinery & Medical Infrastructure Division, we aim to expand our medical-related business and facilitate further growth of our industrial machinery operations, bringing in advanced technology and capturing growing markets.
- Reorganizing into the Energy & Social Infrastructure Division will modify our energy business portfolio to consolidate energy supply, energy generation, and integrated services for end-users into a single business area. Additionally, it will respond to society's increasingly diverse needs by strengthening our efforts in the social infrastructure field, including work on digital technology-related businesses.



 The Metals & Mineral Resources Division will aim to create added value and expand business by developing not only business models based on upstream interests like coal, but also independent businesses which meet new social needs, such as those related to the environment or recycling.

[Corporate Departments]

- As it becomes increasingly important for companies to solve social problems through their business activities, the Corporate Sustainability Office will be established as an organization dedicated to incorporating more sustainable approaches into Sojitz Group's business plans and corporate activities, as well as promoting the creation of "value for society."
- As the digital revolution and technological innovations precipitate greater changes in business models, the Business Innovation Office will be established to act as an organization in perfect alignment with the management, dedicated to facilitating response to these changes, as well as promoting increased work efficiency throughout the company.
- By creating a corporate organization which can provide the business divisions with professional expertise on business investment and M&A, the M&A Management Office aims to help Sojitz achieve its growth strategy and raise the probability of project success and speed of implementation.
- Given that the nine-division system is now well established, the Executive Affairs Management Office, Business Group will be combined with the Secretariat Dept.
- The Financial Planning Office's venture-based investment work will be taken over by the new Business Innovation Office, while their initiatives based in the greater financial climate will be handed off to the Finance Dept.
