### I. Organizational Reforms

#### 1. Organizational Reforms (effective as of April 1, 2020)

[Business Divisions]

- The Energy & Nuclear Business Dept. will change its name to the Energy Business Dept.
- The Apparel & Lifestyle Products Dept. will be formed from a merger between the current General Commodities & Lifestyle Dept. and Textile & Apparel Business Dept.
- A holding company will be established in anticipation of the merger between Sojitz Machinery Corporation, Sojitz Marine & Engineering Corporation, Sojitz Autrans Corporation, and e-Energy Corporation.

#### [Corporate Departments]

• The **Business Accounting Dept.** will be newly established.

#### 2. Purpose of Organizational Reforms

[Business Divisions]

- The Energy Business Dept. will no longer oversee nuclear energy-related business, and corresponding duties will be transferred to the Social Infrastructure Development Office. By transferring these duties, we aim to focus on management of upstream interests, primarily natural gas, as well as strengthen and expand midstream and downstream businesses. Additionally, the Social Infrastructure Development Office will pursue its existing and nuclear energy-related business, while simultaneously utilizing existing customer relationships in related fields to branch out to new business areas such as power storage and energy management.
  - The Apparel & Lifestyle Products Dept. will be formed through a merger between two related departments in order to better concentrate and optimize resources amidst changes to the lifestyle sector's business environment. This reorganization will allow the department to maintain existing businesses while pursuing expansion, as well as help accelerate the process for creating new business models.
- In anticipation of the merger between Sojitz Machinery Corporation, Sojitz Marine & Engineering Corporation, Sojitz Autrans Corporation, and e-





Energy Corporation, a holding company will be established for the purpose of studying and making preparations to merge these four machinery-related subsidiaries in order to pursue large-scale growth and stronger governance.

### [Corporate Departments]

• The Business Accounting Dept. will raise its efficiency and level of specialization in order to better address the increasing sophistication of work processes that accompany business evolution. Sojitz Shared Service Corporation will therefore transfer some of its accounting-related duties to the Business Accounting Dept.
