Ltd. (Head Office: Singapore; Managing Director: Satoshi Fujioka; Established: August 31, 2021; "RSI"), has partnered together with YOTEI PTE.LTD. (Head Office: Singapore; Managing Director: David Ban Song Long; "YOTEI"), the parent company that operates the Japanese TENYA restaurant chain through TENYA SINGAPORE PTE. LTD., to conclude a joint venture agreement on March 20, 2023.


