Sojitz Enters Energy Conservation Business in Australia

- Realizing a Decarbonized Society through the Design and Construction of
Energy Efficient Air Conditioning systems that Reduce CO2 Emissions –

Sojitz Corporation ("Sojitz") will acquire Ellis Air Group Pty Ltd ("Ellis Air") and enter the energy conservation market in Australia. Ellis Air is an air conditioning and mechanical services company providing energy-efficient design and construction services in addition to operations, based in the Australian states of Victoria and Queensland and will become a consolidated subsidiary of Sojitz post the transaction.

Australia has the second highest annual per capita CO2 emissions among G20 countries and the highest annual per capita consumption of energy in the APAC region. During periods of peak energy use, air conditioning and heating account for approximately 50% of all power consumption. Ellis Air specializes in energy-saving air conditioning design and construction which is effective in reducing CO2 emissions.

Additionally, Australia's federal and state governments have announced major CO2 emission reduction targets and related roadmaps. Buildings in Australia are now required to meet high standards for an environmental performance rating. As a result, there is growing awareness and demand for energy-saving air conditioning services.

Sojitz and Ellis Air will expand into the Energy as a Service (EaaS) field to provide comprehensive services tailored to each customer's energy consumption needs with energy-saving solution. Energy data gathered through these businesses will be used as an asset for further business creation and contribute towards the realization of a decarbonized society.
