# Sojitz Corporation Announces Changes to Representative Directors, Directors Appointments following Transition to a Company with an Audit and Supervisory Committee, and Executive Appointments Effective as of April 1st, 2024

At a meeting of the Board of Directors held on January 25th, 2024, Sojitz Corporation passed a resolution approving the following changes to Representative Directors.

Sojitz Corporation has announced it will transition from its current "Company with Audit and Supervisory Board" structure to a "Company with Audit and Supervisory Committee," subject to approval at the 21<sup>st</sup> Ordinary General Shareholders' Meeting scheduled to convene in June 2024, as stated in a separate announcement today entitled, "Notice Regarding Transition to Company with Audit and Supervisory Committee and Partial Modification of Articles of Incorporation." At a meeting of the Board of the Directors held today, Sojitz Corporation has passed a resolution regarding changes to representative directors following its transition to a Company with Audit and Supervisory Committee.

Additionally, Sojitz has passed a resolution approving the following changes to directors and executives as part of the Company's transition to a new structure following organizational reforms effective from April 1<sup>st</sup>, 2024.

#### 1. Reason for the Change

The current Medium-term Management Plan 2023 – Start of the Next Decade – will conclude at the end of March 2024, and Sojitz will embark on Medium-term Management Plan 2026 from April 2024.
