Sojitz Invests in Venture Firm Providing Home Monitoring Service ~Participating in Home Care Business for the Elderly~

Sojitz Corporation ("Sojitz"), together with Management Service Corporation (Head Office: Tokyo; "MSC"), has acquired stake in Anshin Support Co., Ltd. (Head Office: Fukuoka; "Anshin Co."), a venture firm providing a home monitoring service that utilizes emergency call devices and a contact center, via third-party allotment of shares.

Anshin Co.'s predecessor, an incorporated NPO, began offering the service in 2008 targeting the ever-increasing number of households with only a single elderly resident. Now, the service's user base exceeds 10,000 people. The company operates its own contact center which has staff on-site around the clock, including nurses. The service provides 24-hour-a-day monitoring through emergency contact devices provided to users, or via periodic phone calls.

MSC, as an information system service provider to Anshin Co., will make it possible to provide comprehensive support to users' lives by utilizing ICT technologies in the healthcare field to develop more accurate monitoring devices and systems that can perform detailed analyses of customer data, while also advancing contact center systems.

Sojitz will utilize its global network to develop services not only for Japan, but also for markets with aging societies such as China and Southeast Asia. Furthermore, in line with our growth strategy, we intend to construct a comprehensive platform in the healthcare and medical fields by adding online medical diagnostic services to the home monitoring service acquired in this investment.
