I. Organizational Reforms (effective as of April 1st, 2024)

[Business Divisions]

- Energy Solution & Healthcare Division
- The Division will be restructured into the Energy Solution Business Department 1 (Japan/Asia), Energy Solution Business Department 2 (Europe/Middle East), Energy Solution Business Department 3 (Africa/Other Regions), and Energy Solution Business Department 4 (U.S./Australia) to ensure each energy field business will be centralized by region in order to strengthen the company's regional networks and further expand our customer base in each region.
- Aerospace, Transportation & Infrastructure Division
- The Social Infrastructure Business Department will be established to consolidate resources related to aerospace and other transportation fields in addition to airports, industrial parks, and other social infrastructure businesses.
- Metals, Mineral Resources and Recycling Division
- Due to business reorganization, the Non-Ferrous Metals and Minerals Department will change its name to the Minerals Department.

[Corporate Departments]

- The current digital departments will be expanded to include the Digital Business Development Department, Corporate IT Department, and Digital Co-Creation Department. This reorganization aims to accelerate a company-wide digital transformation and to create new clusters of revenue through development of new digital businesses.
- The Finance Department and Financial Solutions Department will be restructured as Finance Department 1 and Finance Department 2.
