Sojitz Expands Automotive Retail Business in San Francisco Bay Area –Acquisition of Franchise Rights for Authorized Subaru Dealership–

Sojitz Corporation ("Sojitz") has newly established Marin Sunwise Motors, Inc. ("Marin Sunwise Motors") to acquire franchise rights and assets for Marin Subaru, an authorized dealership for Subaru brand vehicles in California. Sojitz has now begun sales operations at the Marin Subaru dealership.

Sojitz has opened six authorized dealerships in the San Francisco Bay Area to date (including 3 BMW dealerships, 1 Mini dealership, 1 Audi dealership, and 1 preowned car dealership), and Marin Subaru will be Sojitz's seventh dealership in the area. In addition to its car dealerships, Sojitz also operates two certified collision repair service centers for five brands—BMW/Mini, Audi, Tesla, and Subaru—in the Bay Area.


