Sojitz and Fuji Nihon Seito Invest in Plant-based Meat Company "Tastable"

Sojitz Corporation ("Sojitz") and Fuji Nihon Seito Corporation ("Fuji Nihon Seito") have reached an agreement to make a joint investment in Tastable Co., Ltd. ("Tastable") through a third-party allotment of shares. Tastable, a fully owned subsidiary of Unitec Foods Co., Ltd. (Fuji Nihon Seito 100%; "Unitec Foods"), is engaged in the development, design, and marketing of processed products including plant-based meat NIKUVEGE. (The allotment of shares is expected to be completed on July 1st, 2022. Equity ownership: Sojitz 30%, Fuji Nihon Seito 10%, Unitec Foods 60%)

Sojitz Foods Corporation (Sojitz Corporation 100%; "Sojitz Foods") concluded an exclusive sales contract with Tastable for sales of NIKUVEGE in December 2021. In January 2021, Sojitz, United Foods, and Royal HD concluded a strategic business alliance for a plant-based meat business.\*

Through this investment in Tastable, Sojitz and its partners aim to accelerate growth through a focus on R&D of new materials, increase sales both in Japan and overseas, and create business opportunities in related fields compatible with the plant-based meat business. Sojitz Foods and Meat One Corporation\* have well established sales channels for livestock products and advanced manufacturing and processing technology that bring together Sojitz Group's know-how in the field. Sojitz Group provide raw material procurement, manufacturing, sales, and marketing functions to develop, manufacture, and sell these products for wholesale and commercial consumption.

Demand for plant-based foods is on the rise due to growing health awareness. Additionally, the world's population is expected to reach 10 billion people by 2050. Demand for protein is expected to outpace supply in 2030 leading to a "protein crisis."

Plant-based protein can serve as a solution to this problem, and the plant-based meat industry is also anticipated to demonstrate rapid growth in Japan in the future.

Sojitz Group and Fuji Nihon Seito aim to deliver quality-guaranteed and delicious plant-based meat products to consumers while simultaneously addressing society's issues through new solutions.
