I. Organizational Reforms (effective as of April 1, 2023)

[Business Divisions]

- The Metals, Mineral Resources & Recycling Division's Coal Department will change its
 name to the Coal & Carbon Management Business Department. In addition to handling
 existing coal businesses, the department will strengthen initiatives to build and expand on
 decarbonization initiatives based on customer needs.
- The Retail & Consumer Service Division's Apparel & Lifestyle Products Department and Life Platform Business Department will be merged to form the Retail Business Department 3, which will handle business creation in retail business fields based on consumer goods and basic infrastructure.

[Corporate Departments]

- Under the leadership of CDO and CIO Tomomi Arakawa, the IT Operation Department, ERP Transition Office, and CDO Office will be merged and restructured as two new departments: Digital Department 1 and Digital Department 2.
- The Financial Solutions Department and Portfolio Transformation Office will be restructured, and the Portfolio Transformation Office will be renamed as the M&A Strategy & Value Creation Office. This reorganization aims to facilitate the creation and promotion of M&A and investment strategy as well as to strengthen PMI through consolidation of internal information.
